## **Spanish tax rates and allowances for 2020.**

The income to be declared in this case is the total amount collected from the tenant, without deducting any expenses. If you are an EU resident, the tax rate is then 19% of this “income”, otherwise the tax rate is 24%. This income is chargeable when it is claimable from the tenant or when it is collected (if earlier).
