As soon as you become unemployed, you must file for Massachusetts unemployment, either over the phone, online, or in person through a Massachusetts unemployment office. Anticipate a waiting time of two weeks after submitting a state of Massachusetts unemployment application. From there, you will receive an approval or rejection notice.

Massachusetts Unemployment Benefits and Eligibility for 2020

If you qualify, you receive weekly payments to help cover your living expenses while you search for new employment. The amount you receive is based on what you were paid in the last year. The UI program for Massachusetts is managed by the Department of Unemployment Assistance (DUA).
